**DEPOSIT FOR SERVICE**

A meter deposit of \$150.00 is required for all customers desiring to have service with the City of Weatherford. The deposit may be refunded after one year of uninterrupted, ontime payments of the bill. The deposit requirement will be waived if the customer selects to pay his/her account by bank draft.

**NEW SERVICE/TRANSFER FEE**

All new service and transfer accounts will be assessed a \$20. fee for the connection service. This is not refundable.

1. Minimum commercial rate is \$41.00 for users that do not have a dedicated dumpster.
2. Users with a dedicated dumpster(s) will be assessed according to the rate table below.
3. Out of town is assessed at 1 ½ times the in town rate using rate table below.
4. The minimum number of essential dumpsters will be placed at each location, but the city will make the final decision as to the number of required dumpsters.
