Notice is hereby given that the Board of Adjustment of the City of Weatherford, Oklahoma, will meet on ***Tuesday, September 24, 2019***, at ***5:30 p.m. in Blair Hall, City Hall, Weatherford, Oklahoma***, for the purpose of hearing the following:

- ****Request** by Ritzway Construction and Design Group, for variance to Section 18-53 of the City of Weatherford Code of Ordinances which requires the size of a parking space for one vehicle shall consist of a rectangular area having dimensions of not less than nine feet by twenty feet (9' x 20') plus adequate area for ingress and egress.
- ****Request** by Ritzway Construction and Design Group, for variance to Section 18-54 of the City of Weatherford Code of Ordinances which requires the number of parking spaces for a Hotel or Motel be equivalent to one (1) parking space for each room plus one (1) parking space for each office employee.
