

LEGAL DESCRIPTION: A tract of land lying in the Northwest Quarter (NW/4) of Section Three (3), Township Twelve North (T-12-N), Range Fourteen West (R-14-W) of the Indian Meridian (I.M.), Custer County, Oklahoma more particularly described as follows: Commencing at the SW/Corner of said NW/4; thence North 00°00'45" East along the West line of said NW/4 a distance of 778.00 feet to a point; thence North 89°30'07" East a distance of 435.60 feet to the point; thence South 00°00'45" West a distance of 185.00 the Point of Beginning; containing 8.812 acres more or less.
